Mobilising more volunteers so our community can continue to access the essential services they value and rely on.



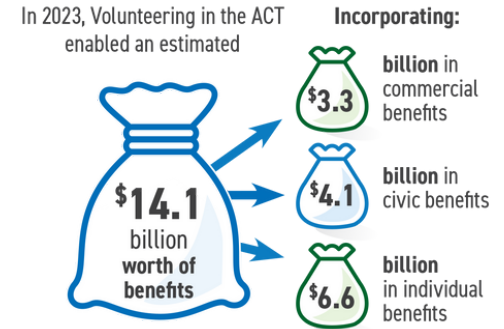
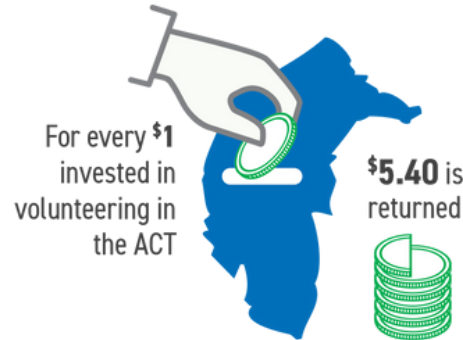
Ensure volunteering is safe, affordable and inclusive for all people who want to volunteer.

ACT value of volunteering to our community

When volunteering is thriving, our community becomes stronger, safer, more connected, more active and better equipped to care for one another, our environment and the animals in our city.



Why should the next ACT government invest in our priorities?

Volunteers ensure essential services continue in food assistance; financial aid; social & emotional wellbeing; community arts, sporting & festive events; environmental & animal protection; emergency responses; health-care & schools.

The **3 biggest changes** of the last 3 years
(as perceived by volunteer managers)



Number of volunteers has decreased



Number of hours people want to volunteer has decreased



Number of young people volunteering has decreased

- Community services and activities that Canberrans value rely on volunteers, but the organisations that provide these services and activities are unable to recruit and retain enough volunteers.
- 19% of current volunteers have stopped volunteering because of increased costs and 18% of non-volunteers had not been asked to volunteer or did not know how to find a volunteer role.
- We can overcome the barriers to volunteering with the right investment:
 - Fully cover the costs of training, equipment, uniforms and insurance.
 - Provide information and support to get involved.
 - Provide training, equipment, recognition and support.

-  Not interested in volunteering anymore

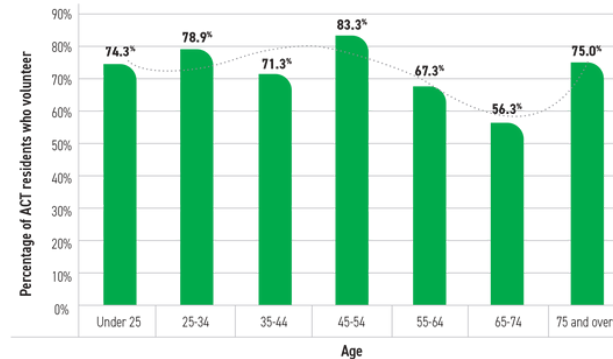


The cost of replacing volunteer labour is estimated to be **\$3.3 billion**
